TERMS AND CONDITIONS/AGREEMENT FOR EXTRACTION/COLLECTION OF ROOMSTICK THROUGH PUBLIC AUCTION UNDER TLABUNG FOREST DIVISION

- The period for collection of Broomstick shall be w.e.f. 01.12.2022 to 30.04.2023. All the extraction
 processes including transportation to final destination should be completed within the period
 mentioned above. Only Broomstick from the Forest areas and Non-Forest Government lands within the
 jurisdiction of Tlabung Forest Division should be collected/extracted.
- 2. No extension of the working period will ordinarily be entertained and any extracted Broomstick lying in the forest which are not transported to the destination after the prescribed period of operation shall become the property of the Government. In exceptional circumstances, Divisional Forest Officer, Tlabung Forest Division reserves the right of extension of the period on merit of each case at its discretion and on payment of charges as may deem fit.
- 3. Any excess collection of Broomstick beyond the stipulated quantity shall be seized and confiscated. The same may be released only after payment of penalty which shall be at least three times the rate per unit quantity quoted for the auction.
- 4. The collection of Broomstick will have to be done skillfully so that means of puplic transport and communication are not endengered/disturbed in any way. The Permit Holder shall be liable to make payment up to double the value of other Forest Produce as assessed by the Divisional Forest Officer/Range Officer concerned if he is found to have damaged any such Forest Produce during the course of operation of Broomstick collection.
- 5. The Permit Holder will have to make his/her own arrangement for transportation of the auctioned materials from the sites including construction of approach road/raft, collection house etc.
- 6. The Department shall not be responsible to make any arrangement for the protection and movement of the Contractor or his/her employees working in the area.
- 7. Transportation of auctioned materials will be done only with Transit Pass to be issued by concered Range Officer after necessary verification.
- 8. The Permit Holder shall have to work in conformity with the general directions of the Forest Officer in charge of the area during the entire process of extraction/collection.
- In case of any kind of dispute arise during the course of operation, the matter shall be referred to the State Government whose decision shall be final and binding on the parties thereto.
