No.A.32015/3/2021-PCCF/91 : On the recommendation of Departmental Promotion Committee meeting held on 06.10.2022 and in the interest of public service, the following Forest Constables are hereby promoted to Forest Head Constable at Level-1A in the Pay Matrix (Rs.18,000 – Rs.39,900) plus all other allowances as admissible from time to time with effect from 1<sup>st</sup> November, 2022 or from the date of joining whichever is later.

On their promotion to Forest Head Constable, they are posted at places mentioned against their names until further order.

They shall exercise option within 1(one) month from the date of promotion, to have their pay fixed under FR 22(1)(a)(i) from the date of promotion or to have their pay fixed initially at the stage on a time scale of pay of the new post next above the pay in the lower Grade, which may be re-fixed on the date of accrual of next increment in the lower Grade i.e. Forest Constable if no benefit under MACP Scheme, 2010 had already been granted prior to the date of promotion, if any.


