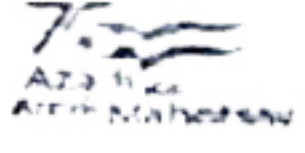

Their regularization is subject to production of Medical Certificate of fitness as well as verification of character and antecedents from concerned Police Station.


They shall be on probation for a period of 1 (one) year from the date of joining their duties. Upon their regularization/appointment, they shall remain in their present places of posting until further orders.
