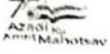

The newly promoted Foresters shall exercise option within 1(one) month from the date of promotion, to have their pay fixed under FR 22(1)(a)(i) from the date of promotion or to have their pay fixed initially at the stage on a time scale of pay of the new post next above the pay in the lower Grade, which may be re-fixed on the date of accrual of next increment in the lower Grade i.e. Forest Guard if no benefit under MACP Scheme, 2020 had already been granted prior to the date of promotion, if any.
