- 6. Identification and Quantification of Mineral Resource and its optimal utilization.
- 7. To maintain the livelihood of aquatic habitat.
- 8. To keep accumulated data records viz. details of Mineral Resource, potential area, lease, approved mining plan, co-ordinates of district at one place.
