NOTIFICATION

Aizawl, the 4th Aug' 2015

As required under Rule 4(1) and 5 of the Mizoram Information Technology (Electronic Service Delivery) Rules, 2015, the public services of the Environment & Forests Department which can be delivered through electronic mode are as follows :-

1. Tender Form
2. Pvt. Plantation Registration Form
3. Pvt. Plantation Felling Permit Form
4. Wildlife Compensation Form
5. Application Forms for Saw Mill, Secondary Woodbase Industries etc.

The above services shall be made available in the Department website within 1(one) month from the date of issue of the notification.

To achieve the above objective the following procedure shall be strictly complied with by all concerned :-

- 1) All forms shall be furnished to the Officer incharge of web-site immediately after the same is approved by competent authority.
- 2) Officer incharge of web-site must upload the same immediately without any delay. In case of server being unavailable, the official concerned should ensure that the same is uploaded immediately after the server is restored.
- 3) The Nodal Officer for service delivery will inspect such results periodically for effective implementation.
- 4) The Nodal Officer shall keep on exploring possibility of any other services that can be rendered by the Department and incorporate those services into the web-site.

Pu Lalthangliana Murray IFS, CCF (Admn.) is hereby designated as Nodal Officer for delivery of each such service through electronic mode.

The Competent Authority shall thereafter, review and update these publications every year or as frequently as required.

Further, the following authorities are hereby designated as signing authorities in respect of different public services as mentioned above for a period of 1(one) year from the date of issue of this Notification with the extent of jurisdiction as mentioned against their names :-
