**TERMS AND CONDITIONS FOR AUCTION SALE OF LOGS AT TLABUNG**

(vide Auction Notice issued vide No. B.12013/40/2016-DFO(TLB)/1749-1753  
Dt. 21.11.2019


1. The intending bidders shall have the liberty to inspect the timbers before the auction, and any subsequent complaint as regards to shortage of Forest Produce, Quality of timber, extraction routes or the like shall not be entertained.
2. The undersigned may postpone the auction sale on reasonable grounds but shall in such case, issue fresh proclamation indicating the new date fixed for the auction.
3. On the date fixed for auction, the Officer authorized to hold the auction shall call for the bids from intending bidders present: Provided that if there is no bid or insufficient bid, he may continue the sale from day to day informing the bidders on the spot.
4. The auction shall normally be closed in favour of the highest bid received and the final sale shall be made with the highest bidder subject to the production of requisite documents for proof of identity and that the bid value exceeds the floor price fixed by the undersigned. However, the undersigned reserves the right to dispose the auctioned materials to individuals/parties whose bid amount is not the highest but higher than the floor price.
5. The undersigned or the officer holding the auction reserves the right to reject any bidder without assigning any reason thereof.
6. No appeal shall lie against the sale to the highest bidder in any auction.
7. The successful bidder shall pay 100% of the sale-value of the auctioned materials to RO concerned (Tlabung/Lungsen/Chawngte L) on the date of auction. The undersigned shall however have the right to extend period of payment of sale-value on reasonable ground if required. The successful bidder will be allowed to lift the log timber only after payment for sold timber in full (100%) and on completion of all necessary paper works.
8. No timber lot shall be sold jointly to more than one person.
9. In any cases, no lifting/transporting of sold timber shall be allowed without valid Transit Pass (TP) issued by concerned Range Officer. Further, TP shall also be countersigned by DFO, Tlabung.
10. The sold log timber shall be transported to destinations (Mizoram or India) by road through the indicated route in the Transit Pass. No movement of

sold timber by boat along the river shall be entertained. Further, the sold timber found being transported to other locations via other routes different from those mentioned in the Transit Pass shall be liable to seizure and confiscation to Government property.

11. The sold timber shall be transported during the validity period mentioned in the Transit Pass only, failing which will automatically make the timber illegal and liable to seizure.
12. If the successful bidder fails to pay the sale value, the settlement in his favour will automatically stand cancelled, and he/she shall be notified as a defaulter.
13. The Forest Officer holding the auction shall not be responsible for any loss or damage of log timber after finalization of successful bidder. The successful bidder shall be responsible for the safety of log timbers he/she bough from the auction.
14. If the bidder whose bid amount has been accepted fails to pay the bid amount as stipulated or to execute an undertaking mentioned above, the sale of the timber in his favour shall be cancelled, and the timber shall be resold, either to the next suitable bidder at the risk of the defaulting bidder whose payment if already deposited shall be forfeited to the Government as Forest revenue.
15. No power of attorney or mortgage deed or any encumbrance shall be recognized in respect of any timber lot except when executed with previous permission in writing from the authority competent to pass order of acceptance of the auction.
16. The DFO, Tlabung shall have the right to withdraw auction sale at any time before issue of final order of acceptance of the auction, and in case of conflict, the right of the former shall prevail.
